Directions and Maps



There are many ways to get to the Comparative Testing Office (CTO), below are suggestions. If you are travelling here, recommend you have a map and use either taxis or metro rail (both relative inexpensive and parking is hard to find and costly). If you use Map Quest, use intersection of 18th Street & Crystal Drive as our location. During inclement weather, you can proceed using the Crystal City underground--follow the signs from the Metro. Call if you get lost and need help, it can be confusing. Maps hyperlinked below supplement directions.

By Metro Rail - Take either the yellow or blue line to the Crystal City metro stop. Take the escalator completely to the top, turn left and cross 18th St. Then turn left again and cross S. Bell Street, proceed across the brick plaza to the front entrance of Crystal Mall 3 (1851 S. Bell Street is written above the doors and U.S. flag on top of building-see left photo above). Enter the lobby on the main or 1st floor and proceed to the guard desk.

By Taxis - Cab drivers will probably know where Crystal Drive is, so recommend you ask to go to 18th and Crystal Drive. Proceed to the rear entrance of Crystal Mall 3 at the loading dock-see right photo above, take the elevator to the lobby on the main or 1st floor. Proceed to the guard desk.

From Reagan National Airport - By metro rail, follow the signs and ride the escalator to the the metro rail stop just outside. Follow above metro rail instructions. If driving follow the airport signs to Crystal City, exit right on to Crystal Drive heading north. Just beyond 18th Street and Crystal Drive, there is a parking garage on the left beyond the Post Office. See below*.

From Dulles International Airport - Proceed East on Dulles Airport Access Road to Interstate 66, exit east on to 110 that turns into U.S. Highway 1 (both labeled Jefferson Davis Highway), exit right on to 12th Street heading West and then a left on Eads Street heading South. Make a left heading East on 18th Street and another left, North, on Crystal Drive. Park at the paid parking garage on the left of Crystal Drive just beyond the Post Office. See below*.

From Downtown Washington, D.C. - If you are driving from downtown, cross over the 14th St Bridge heading South on Interstate 395, and then take U.S Highway 1 (Jefferson Davis Highway) exit in the far left hand lane (in traffic, this is tough to do). Take the first exit ramp on to 12th Street heading West and then a left on Eads Street heading South. Make a left heading East on 18th Street and another left, North, on Crystal Drive. Park at the paid parking garage on the left of Crystal Drive just beyond the Post Office. See below*.

From the South on 395 - Heading North take the Pentagon City exit to the right and make a left at the light on to Army Navy Drive heading East and then a right on Eads Street heading South. Make a left heading East on 18th Street and another left, North, on Crystal Drive, and then park at the paid parking garage on the left of Crystal Drive just beyond the Post Office. See below*.

***A large waterfall display is across the street from the parking garage. After parking, walk back out to Crystal Drive, turn right going South, cross 18th Street and enter the rear entrance of Crystal Mall 3 at the loading dock (see right photo above), take the elevator to the lobby on the main or 1st floor.**

Proceed to the guard desk for a visitor pass and call 602-3740 for an escort. The Comparative Testing Office is located through the double doors, make a right, and go to Suite 101 (marked).
