The Richard “Dick” Ginman Contingency Contracting Officer Excellence Award

1. **ELIGIBILITY:** Military members or Government civilian employees within the DoD acquisition/contracting community at any grade level who meet the criteria as detailed below throughout the preceding calendar year.
2. **BACKGROUND:** Contingency Contracting Officers (CCOs) are some of the first responders to an emergency, humanitarian and disaster relief, or operational contingency. They often deploy with little more than a laptop and an understanding of the mission, concept of the operation, and commander’s intent. Contingency operations require a tremendous amount of work, improvisation, and dedication from our CCOs. This annual award honors those whose actions as a Contingency Contracting Officer are truly inspirational.

The award is named after Richard “Dick” Ginman, a retired Navy Supply Corps Admiral and former Director of Defense Procurement and Acquisition Policy (DPAP). Mr. Ginman has steadfastly proven to be one of the staunchest supporters of CCOs and the contingency contracting mission. The first award was presented by Mr. Ginman. Successive awards will be presented annually by the Director of DPAP in OUSD(AT&L).

The Richard “Dick” Ginman Contingency Contracting Officer Excellence Award will be implemented in the same manner as the Acquisition and Contracting Legends Award.

3. **AWARD CRITERIA:** The Richard “Dick” Ginman Contingency Contracting Officer Excellence Award recognizes CCOs at all levels in the DoD acquisition/contracting community who have deployed, accomplished the mission, and excelled through adversity in supporting contingency operations. The nominee who is selected for this honor will be recognized at an Acquisition Community Senior Leader Meeting, generally held annually at the Pentagon.

Nomination narratives must provide a concise background for context, and should clearly demonstrate why the nominee’s accomplishments warrant recognition by this award. Nominations shall be limited to a single, 8.5x11 page, 1 inch margins, 12 font. The nomination should address the following three criteria, Mission Requirements, Actions/Results, and Overcoming Challenges:

- a. Mission Requirements: (Describe the contingency/operation/mission requiring CCO support).
- b. Actions/Results: (Describe the tasks the CCO completed and how the results provided exceptional and timely support to the mission and commander’s intent).
- c. Overcoming Challenges: (Describe any hardships/obstacles endured and how the CCO innovatively overcame adversity to ensure contract awards were timely to warfighter needs, compliant with prescribed policies and regulations, and in the best interest of the U.S. Government and taxpayer).

In addition to the one-page write-up, submissions should include the nominee's biography, also limited to one page.

4. INSTRUCTIONS:

a. The Director of DPAP will solicit nominees annually from the components for this award.

b. Each component may nominate one individual for each cycle. Nominations will be no longer than two pages in length, one page nomination and a one-page biography. Forward nomination packages to Col Maria Schneider, maria.d.schneider.mil@mail.mil no later than September 15, 2016.

c. The Deputy for Contingency Contracting will provide recommendations to Director, DPAP, who will select the award recipient(s).

d. The Director, DPAP will present the award recipient(s) with a letter of recognition and appropriate award.

e. The individual(s) selected for the Award will be posted online on the DPAP webpage.
