1.6.1.1. Non-Cumulative Time Phased to Date: A Historical Contract Performance Data file will be required in place of the normally provided CPD **monthly/annually/upon request [choose, delete as appropriate]**.

2.3.2. Performance Data: The CPD shall be submitted in dollars and hours down to the **control account/work package level [choose level, delete as appropriate]**.

2.3.2.2.1. Indirect Costs: Reported Indirect costs are Cost of Money (COM), General and Administrative (G&A) and Overhead (OH). NonAdd settings are used to indicate indirect metrics (OH, COM, and G&A) which are included in the detailed cost metrics (a NonAdd setting of TRUE, indicates that the corresponding indirect cost is included (burdened on) the details cost metrics).

Summary Performance: Summary performance cost and hours metrics (including total indirect values as well as the total PMB values) must be provided within the Summary Performance table as per the FFS/DEI. Summary performance metrics must be provided and consistent with the defined indirect NonAdd flags.

2.4.2.21. Schedule Risk Assessment (SRA): In addition to IPMDAR DID requirements for SRAs and the reporting of any SRAs conducted internally by the Contractor, the Contractor shall perform and report the results of additional SRAs on a **quarterly/semiannual/annual [choose one, delete as appropriate]** basis against any such milestones as the Government may direct, and with such inputs and participation as the Government requests. An SRA may also be requested to support Government Estimate-at-Complete (EAC) processes.

Item 17. Specify appropriate price group from one of the following groups of effort in developing estimated prices for each data item listed on the DD Form 1423.

a. Group I. Definition - Data which is not otherwise essential to the contractor's performance of the primary contracted effort (production, development, testing, and administration) but which is required by DD Form 1423.

Estimated Price - Costs to be included under Group I are those applicable to preparing and assembling the data item in conformance with Government requirements, and the administration and other expenses related to reproducing and delivering such data items to the Government.

b. Group II. Definition - Data which is essential to the performance of the primary contracted effort but the contractor is required to perform additional work to conform to Government requirements with regard to depth of content, format, frequency of submittal, preparation, control, or quality of the data item.

Estimated Price - Costs to be included under Group II are those incurred over and above the cost of the essential data item without conforming to Government requirements, and the administrative and other expenses related to reproducing and delivering such data item to the Government.

c. Group III. Definition - Data which the contractor must develop for his internal use in performance of the primary contracted effort and does not require any substantial change to conform to Government requirements with regard to depth of content, format, frequency of submittal, preparation, control, and quality of the data item.

Estimated Price - Costs to be included under Group III are the administrative and other expenses related to reproducing and delivering such data item to the Government.

d. Group IV. Definition - Data which is developed by the contractor as part of his normal operating procedures and his effort in supplying these data to the Government is minimal.

Estimated Price - Group IV items should normally be shown on the DD Form 1423 at no cost.

Item 18. For each data item, enter an amount equal to that portion of the total price which is estimated to be attributable to the production or development for the Government of that item of data. These estimated data prices shall be developed only from those costs which will be incurred as a direct result of the requirement to supply the data, over and above those costs which would otherwise be incurred in performance of the contract if no data were required.
