

SUBJECT: Delegation of Authority Under Section 801 of the National Defense Authorization Act (NDAA) for FY 2008

Subsection (b)(1) of section 801 of the NDAA for FY 2008, Public Law 110-181, "Internal Controls for Procurements on Behalf of the Department of Defense by Certain Non-Defense Agencies," requires that a Department of Defense (DoD) acquisition official may place an order, make a purchase, or otherwise procure property or services for the Department in excess of the simplified acquisition threshold (\$100,000) through a non-defense agency only if the head of the non-defense agency has certified that the agency will comply with defense procurement requirements for the fiscal year.

For the purposes of this section, a non-defense agency is compliant with defense procurement requirements if the procurement policies, procedures, and internal controls of the non-defense agency applicable to the procurement of products and services on behalf of the Department and the manner in which they are administered are adequate to ensure the compliance of the non-defense agency with the requirements of laws and regulations (including applicable DoD financial management regulations) that apply to procurements of property and services made directly by the Department. A procurement shall be treated as being made during a particular fiscal year to the extent that DoD funds are obligated for the procurement for that fiscal year.

Subsection (b)(2) of section 801 provides that the limitations imposed on procurements by a non-defense agency do not apply during any fiscal year in which there is in effect a written determination of the Under Secretary of Defense for Acquisition, Technology and Logistics, that "it is necessary in the interest of the DoD to continue to procure property and services through the non-defense agency during such fiscal year."

I hereby delegate to the Director, Defense Procurement and Acquisition Policy, the authority to make such determinations and the authority to extend the period for which any determination is in effect. This authority is effective until rescinded or until Section 801 is repealed or modified. My point of contact is Mr. Michael Canales, DPAP/CPIC, at 703-695-8571.
