SUBJECT: Contractor Past Performance Assessment Reporting – 2nd Quarter FY 2014

Contractor past performance reporting is a focus of the Office of Federal Procurement Policy (OFPP) and is of importance to the USD(AT&L). I am tasked with monitoring and communicating how the Department is performing on a quarterly basis.

The attached spreadsheet identifies the Past Performance Information Retrieval System (PPIRS) compliance metrics as of March 28, 2014, and compares the FY14 second quarter data of 83.19% against the first quarter data of 81.51%. There is still a lot of effort required to improve compliance to meet the Department's goal of 95% in Fiscal Year 2014 set by OFPP.

The contract count includes contracts and delivery orders from the Federal Procurement Data System (FPDS) that meets the DoD threshold whether the action has been registered or not in the Contractor Performance Assessment Reporting System. The contract completed count reflects those actions that are complete and available in the PPIRS for source selection.
