SUBJECT: Contractor Past Performance Assessment Reporting - 2nd Quarter Fiscal Year 2015

The Office of Federal Procurement Policy continues to focus on contractor past performance reporting. This reporting is also of importance to the USD(AT&L). Likewise, we are tasked with monitoring and communicating how the Department is performing on a quarterly basis.

The attached spreadsheet identifies the Past Performance Information Retrieval System compliance metrics as of March 27, 2015, and compares the Fiscal Year (FY) 15 second quarter data of 80.82% against the first quarter data of 80.43% for an increase of less than one percent. The goal for FY15 is 100% compliance.

I appreciate the effort of agencies that have improved their compliance. I encourage everyone to do better, especially those that are under 70% compliance, as we have a long way to go to meet the FY15 goal.
