SUBJECT: Contractor Past Performance Assessment Reporting – 2nd Quarter 2012

The Acting USD(AT&L) memorandum dated November 18, 2011, “Past Performance Assessment Reporting,” tasked the Director of Defense Procurement and Acquisition Policy to monitor and communicate compliance information to the senior procurement executives on a quarterly basis.

The review of the compliance metrics in PPIRS as of April 6, 2012, identified the overall average for 2009-2012 in the Department as 47%. When compared to the previous quarter (January 3, 2012 data), there is an overall decrease of 12% from 59% compliance.

The attached spreadsheet identifies specific agencies with their overall scores. There are a significantly higher number of contracts in the second quarter of FY12 since the period of performance for many contracts ended at the close of FY11 and assessments were due within 120 days. Attention must be paid to providing the completed assessments in a timely manner.
