SUBJECT: Contract Deficiency Report Reason Codes

The contract deficiency report (CDR) module in the Electronic Document Access (EDA) system is being replaced by a new module in Wide Area Workflow (WAWF). As part of this migration, the existing CDR reason codes were reassessed and updated for implementation in the new WAWF module.

The Defense Federal Acquisition Regulation Supplement, Procedures, Guidance, and Instruction 204.270-2 requires that contracting officers "review and act upon contract deficiency reports" for contracts identified as missing or containing incorrect data. Contracting officers shall identify these deficiencies with the attached allowable CDR Reason Codes. To ensure better operational integrity, the use of "other" as a valid reason code has been eliminated as recent analysis indicated that 75% of all reason codes were filed as "other." Furthermore, duplicate codes have been consolidated, and new values have been added.
