
SUBJECT: Contractor Past Performance Assessment Reporting – 3rd Quarter 2012

The Acting USD(AT&L) memorandum dated November 18, 2011, “Past Performance Assessment Reporting,” tasked the Director of Defense Procurement and Acquisition Policy to monitor and communicate compliance information on past performance reporting to the senior procurement executives on a quarterly basis.

The review of the compliance metrics in PPIRS as of July 3, 2012, identified the overall average for 2009-2012 in the Department as 62%. When compared to the previous quarter, there is an overall increase of 3%, an encouraging sign but we must continue to improve.

The attached spreadsheet identifies specific agencies with their overall scores for the third quarter of FY2012. There are only three agencies that have a percentage of 80 or higher and three in the 70 percent range. There is still much work to be done as there are many overdue reports that hinder reaching a higher percentage. Contractor performance evaluations are due within 120 days of the end of a period of performance. Attention must be paid to providing the completed assessments in a timely manner.
